

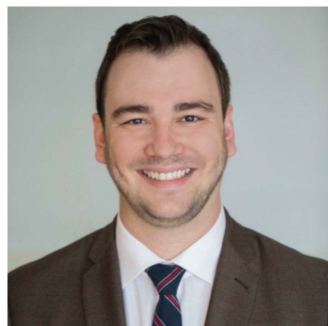

## Anthony Cardillo, MD

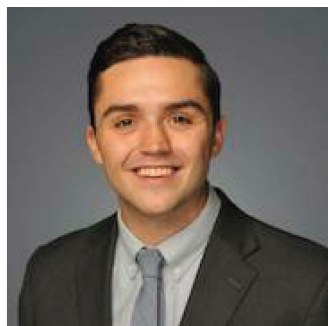
**Hometown:** Little Rock, AR
